# Using Workers' Compensation Data for Prioritizing Risk and Preventing Occupational Injuries

This session will discuss methods developed by the Ohio Bureau of Workers' Compensation (OBWC) for analyzing injury claims and policy data for prioritizing specific industry groups, policies, and populations of workers for safety interventions.
